The undersigned, acting as incorporator(s) to form a corporation under the Hawaii Nonprofit Corporation Act, adopt the following Articles of Incorporation:

Article One: The name of the Corporation is: Kukini Dog Agility Club

Article Two: The Corporation commences upon the date these Articles are signed by the initial incorporators/officers of the corporation and shall continue until dissolved by its members.

Article Three: The Purpose for which the corporation is organized is:
